

Yorkshire and Humber hit with worst construction skills shortage in 20 years



Yorkshire and Humber's construction industry is experiencing its greatest skills crisis since 1998, a survey by the Royal Institution of Chartered Surveyors has revealed.

The quarterly UK Construction Survey shows that the skills shortage in Yorkshire and Humber has reached its highest levels since the survey was launched 18 years ago, with bricklayers and quantity surveyors in shortest supply. 50% of respondents reported difficulty sourcing labour, with 52% having difficulty sourcing

bricklayers, whilst 62% also highlighted a shortage of quantity surveyors. In the same time period in 1998, just 18% of Yorkshire and Humber's construction companies reported a skills shortage.

In addition to labour supply, 69% of firms revealed that financial constraints, such as access to credit, were among the biggest constraints to growth, while 60% said that regulatory and planning issues were potent constraints. Despite these ongoing issues, however, the survey shows some areas of growth, with the number of new construction projects increasing in Yorkshire and Humber, particularly in private housing, commercial and industrial sectors.

Pensions Minister backs online course devised by Hull firm



The Government's Pensions Minister has given her backing to a nationwide scheme which is using expertise from an FSB member in Hull to help more than a million employers prepare for auto enrolment.

golding computer services Baroness Ros Altmann says improving awareness of the issues around pension provision is crucial to helping the smaller businesses hit their deadlines. The Minister has been leading the TV campaign to promote "Workie", the brand mascot created by the Department of Work and Pensions as part of an £8 million marketing campaign. She also praised the online course offered by the Chartered Institute of Payroll Professionals using material from Golding Computer Services.

The CIPP launched its service ahead of a New Year trigger which will see auto enrolment adopted by more than half a million small and micro businesses during 2016. Central to the service is the expertise of Goldings, which has provided the CIPP's "Automatic Enrolment Specialist Course" and the companion "Automatic Enrolment Technical Specialist Course".

Auto enrolment legislation was introduced in 2013 and means all employers must automatically enrol all staff into a pension scheme and make contributions to that scheme unless employees opt out. Penalties for failing to comply start at £400. Vic Golding, Managing Director of Goldings, said: "The specialist course uses slides and a voiceover to show an audience from business owners to their accountants and consultants the latest high level thinking about auto enrolment. The technical specialist course covers the opportunities offered by technology."

Number of UK firms reaches record high

According the latest business population estimates published by National Statistics, the number of private sector firms in the UK at the start of 2015 reached an all-time record of 5.4 million. This includes 3.3 million sole proprietors, 1.6 million companies and 436,000 ordinary partnerships.

The net annual change amounted to 146,000, indicating that more firms had been started than had closed. The new business population estimate also revealed that there are almost a million more private firms and self-employed people in the UK now than there were in 2010.

The number of firms employing staff also rose by 35,000 in the year to January 2015, and it was found that the number of medium-sized firms employing between 50 and 249 staff grew by 1,000 during the same period.

£4m boost for video games development sector



A new £4 million fund has been launched to boost the UK video games development sector, particularly newly established developers.

The Video Games Prototype Fund will award grants of up to £25,000 to help 'new and young' developers create working prototypes. It will also provide a limited number of developers with grants of up to £50,000 so they can take their games beyond the prototype phase. The Prototype Fund will be run by UK Games Talent

and Finance, a Community Interest Company, until 2019.

New programme to boost leadership in small firms

UK small firms are set to benefit from innovative new projects to improve their leadership skills and productivity, following the launch of the UK Futures Programme run by the UK Commission for Employment and Skills.

Under the programme, eight local 'anchor institutions' will work with UKCES to pilot new ways to boost leadership in small firms who haven't previously had any leadership or entrepreneurial training. The anchor institutions include chambers of commerce, universities, colleges, councils,

enterprise agencies, learning partnerships and business schools, working in conjunction with local employers.

Julie Kenny, Commissioner at UKCES, said: "Small businesses form the backbone of the UK economy. Yet constraints on their time and resources mean they are the least likely to develop the leadership and management skills that will help them grow. The anchor institutions we will be working with have demonstrated a strong understanding of the specific issues that small businesses face in their local community. They have also shown that they have the ability to reach out to businesses who often find themselves excluded from national programmes."

BCC calls for return of compulsory work experience

The British Chambers of Commerce has published early findings from its 'Business and Education Survey', which was carried out in July and August 2015. A key finding is that 82% of business respondents want schools to provide work experience opportunities for pupils aged under sixteen. As a result, the BCC has called on the Government to bring back compulsory work experience.

John Longworth, Director General of the BCC, said: "Work experience is crucial to bringing down our stubbornly high youth unemployment rate. It will help ensure more young people are prepared for work. It will help close the yawning skills gaps reported by frustrated businesses across the UK, who face huge difficulty filling vacancies at every level."

Funding boost for rural community projects



Rural firms are to benefit from LEADER funding worth £138 million to develop projects that will boost their local economy and create jobs through farm diversification, tourism promotion and the support of cultural heritage.

LEADER is an EU-wide scheme that is part of the Rural Development Programme which runs until 2020 and is worth a total of £3.5 billion. The funding will be allocated to 80 Local Action Groups, to be selected on a competitive basis,

which will deliver a specific amount of funding for their local area. Projects completed under the previous LEADER funding round included the conversion of farm buildings in Derbyshire into tourist accommodation and the expansion of premises for a sausage-making firm in Norfolk.

New guidance about zero-hours contracts published

The Department for Business has published guidance for employers about how zero-hours contracts should be used appropriately.

The guidance provides examples of best practice, such as clearly advertising that a job role will be under a zero-hours contract and that the hours will not be guaranteed. It also states that late cancellation of work is unacceptable except in "truly unavoidable" circumstances. Suggested alternatives to zero-hours contracts outlined in the guidance include offering existing staff overtime, recruiting a part-time employee or using temporary staff from an agency.

Guide to preventing discrimination against ex-offenders



Business in the Community has published a guide for employers to help them develop fair recruitment policies and to prevent discrimination against ex-offenders.

'Fair Recruitment of People with Criminal Convictions' has been published as part of the Business in the Community 'Ban the Box' campaign to encourage employers to stop using the criminal record tick box on job application forms. Business in the Community believes that questions on

employment application forms asking about an individual's criminal record is discrimination against job seeking ex-offenders.

A recent survey of prisoners at HMP Nottingham revealed that, while 91% of prisoners claim that they want to work once they are released from prison, only 53% would tick the box and be honest about their criminal convictions.

Two consultations on reforms to recruitment sector

Two consultations have been published by the Department for Business on reforming legislation of the recruitment sector and dealing with exploitation in the labour market.

Plans are being made to prevent recruitment firms from recruiting solely from overseas without advertising in Great Britain and in English. A new criminal offence is also being considered to deal with employers who hire migrant workers and then subject them to illegal working conditions and pay. Four proposals are being considered to assist with the effectiveness of the current regime: a new offence of aggravated breach of labour market legislation; a wider remit for the Gangmasters Licensing Authority; a new Director of Labour Market Enforcement; and increased data sharing between existing enforcement bodies.

HMRC carrying out more employer compliance reviews

HMRC carried out 2,488 employer compliance reviews between April 2014 and March 2015, which is an increase of 13% from the previous year's figures. The reviews investigate employers that are suspected of underpaying employment taxes.

If an organisation is found to have underpaid employment taxes, HMRC can issue fines of up to 30% of the tax owed. In instances where HMRC believes that an employer has intentionally attempted to evade employment tax, a fine of up to 60% can be issued.

Chris Thomas, from Pinsent Masons said: "Employers would be well advised to get their houses in order, review the robustness of their systems and disclose any historic problems to HMRC before it comes to them."

HMRC to scrap business record checks

The business record check initiative is to be wound down, the Chartered Institute of Taxation has reported. Checks were introduced by HM Revenue and Customs four years ago to make sure all statutory business records were correct and up to date, and have been subject to much criticism for being ineffective and poorly targeted.

Two year plan to increase take up of R&D tax relief

HM Revenue and Customs has announced a two-year plan to increase take-up of research and development tax relief among small firms.

Measures will focus primarily on increasing awareness and making it easier for firms to apply for this type of tax relief. For example, HMRC will publish improved guidance to help increase firms' understanding of R&D tax relief and provide business certainty through the Advance Assurance scheme. Under the Advance Assurance scheme, which will launch this month, HMRC will assure eligible firms that their first three years of R&D tax relief claims will be allowed "without enquiry".
