FSB Regional Chairman's New Year message

2016 will be a year of big decisions for small businesses. In November FSB updated our brand to reflect the UK's dynamic and changing small business sector. More and more business is being conducted online and the entrepreneurs leading it are more diverse than ever before - as are the business models they rely on. Our members expect more from us: we can't just be the voice of small business anymore – they want us to be experts in business too – offering more advice, further support and taking greater leadership on the issues which matter to them. This is the sort of ongoing change any successful business needs to take in its stride.

Last year we saw a change to the UK Government, and the first majority Government elected since 2005. 2016 will see elections for local authorities and Police and Crime Commissioners across our region. Each of these will set the political agenda

for small business, putting in place Mayors, Councillors and Commissioners who will all take decisions that impact on small firms and change the business landscape. We may even see the scheduling of a referendum on the UK's membership of the European Union. FSB will be monitoring events closely, making sure small businesses are at the heart of the debate and our voice is heard, and challenging those standing for election to demonstrate they have solutions to the real problems small business face, such as late payment or poor access to finance.

This year will see the introduction of new policies like the National Living Wage, the small business rollout of the workplace pension, changes to dividend taxation, and the introduction of the Apprenticeship Levy. Each of these changes will bring their own challenges and require all businesses to adapt – but they also present opportunities.

It's right for businesses to share the fruits of success with their staff, help them save for retirement and invest in training the next generation of employees. But some businesses, particularly in retail, health and social care will struggle to make the changes needed to meet this challenge. However the change will also force innovation to improve productivity and find new ways to do business. FSB's role will be to make sure that where change is proposed, it is well thought-through and small businesses are properly consulted and supported. Our grassroots are what make us different, and the evidence we source from our membership will be invaluable to policy makers in 2016.

In March we will be in Glasgow for our annual UK National Conference, with blockbuster political speakers to be announced. Members will be listening hard, and expressing what they need to drive the economy. I'm sure 2016 will involve both new challenges and opportunities – but we've never been afraid of change.

What can your MP do for you?



MPs can assist businesses in a variety of ways, from making private enquiries on their behalf, to raising matters publicly in the House of Commons.

They might write to the relevant department or official, send a letter to the appropriate Minister or make a personal appointment to discuss the issue. Or they may decide to make the issue public by raising it in the House of Commons, where it will be officially recorded, and could potentially come to the attention of the press and public.

Businesses could also request that their MP speak at an event concerning the issue, pledge their support to a campaign or write to the local media on their behalf.

£36.2m Hull music venue to be built by Bam Construction



Bam Construction has been appointed by Hull City Council to build a new, state-of-the-art music, events and conference centre in the city.

BAM, whose previous projects include the First Direct Arena in Leeds and One Angel Square in Manchester, will begin work immediately on Stage 1 of the project involving preliminary, pre-

construction services.

Proposals for the new venue aim to attract major events, conferences and music concerts to Hull, and are integral to Hull's legacy planning following from its year as UK City of Culture 2017. Detailed feasibility studies and market testing show that the facility will inject £13.5m into Hull's economy annually, delivering 30 full-time jobs with 100-150 temporary jobs on event days.

The centre will include a 3,500 capacity concert auditorium, with the flexibility to reduce to a 2,500 all-seated event and a 2,000m2 exhibition space, plus an 800 capacity conference auditorium. Hull City Council has committed £36.2m towards the cost of building the complex on the site behind Princes Quay shopping centre, where new retail facilities and a hotel are proposed.

Situated close to the key road and rail routes in and out of Hull, the new Hull Venue will revitalise and reconnect the city centre by providing a link between the historic Old Town, the 1950s-built 'new town' and the city's transport interchange and St. Stephen's shopping centre. The aim is to provide an iconic landmark for visitors travelling to and through the city, as well as offering conference delegates and gig-goers spectacular views of Hull Marina.

Work on the development will begin later in 2016, with completion scheduled for early 2018.

Police funding in South Yorkshire – your opportunity to speak out



One of the responsibilities of the Police and Crime Commissioner is to set the annual budget for policing. A small proportion of the cost of policing is paid from council tax (25%) with the rest coming directly from the Government via the police grant (75%). The local council tax element – the precept – is set by the Police and Crime Commissioner.

The Government recently announced that there would be no cuts to police funding next year. This was a little misleading. What has now become clear is that the police grant will be reduced by $\pounds 1m$ and there will be no provision for inflation - such as increases in salaries and additional demand on police services, which comes to about $\pounds 7$ -8 million.

The South Yorkshire Police and Crime Commissioner has a statutory duty to consult the public and businesses on the council tax precept. He has therefore published a short questionnaire to hear your views.

Employers advised to prepare for National Living Wage

The Department for Business has advised employers to begin preparing for the introduction of the National Living Wage. The National Living Wage is set at £7.20 per hour and comes into force on 1 April 2016 for employees aged 25 and over. The Department for Business is advising employers to identify all eligible employees, communicate the changes to them as soon as possible, and update their company payroll accordingly.

This follows the publication of the results of a survey by The Department for Business about the introduction of the National Living Wage. The survey revealed that only 45% of employers had updated their payroll and only 39% had communicated the change to their employees.

Up and coming employment legislation

The following employment legislation has now been confirmed as coming into force in the early part of 2016:

- The Small Business, Enterprise and Employment Act 2015 (Commencement No. 3) Regulations 2015 bring into force on 1 January 2016:
- The Exclusivity Terms in Zero Hours Contracts (Redress) Regulations 2015 will come into force on 11 January 2016.

- The Public Interest Disclosure (Prescribed Persons) (Amendment) (No. 2) Order 2015 will come into effect on 1 February 2016.
- The National Minimum Wage (Amendment) Regulations 2016 will come into force on 1 April 2016.

62% of business owners make critical decisions on their own

According to a survey by AXA PPP healthcare, 62% of small business owners make difficult business decisions on their own, with 9% having nobody to turn to for advice.

Of those who have access to support, 19% would rely on other directors or business partners if they had an issue, 16% would use a networking organisation to talk to fellow business owners, and 21% would rely on family to help them with their decisions. The survey also found that 16% of business owners would like more help with business planning, 42% would like more support to run their business, and the same number would like better help with accessing finance. When asked about the main business pressures they were facing, 13% cited cash flow, and 11% cited meeting regulatory requirements.

Only one in ten self-employed individuals contributing to a pension

The number of self-employed individuals contributing to a pension has fallen significantly over the past decade, according to pension provider Prudential.

An analysis of HMRC and Office for National Statistics data, carried out by the Prudential, revealed that only one in ten self-employed individuals contributed to a pension in 2013/14, compared to one in three in 2001/02. The analysis also found that the total value of self-employed pension contributions has fallen by 35% over the past 12 years.

Vince Smith-Hughes, a retirement expert from Prudential, said: "It is understandable that re-investing any spare cash into a business is a priority for many entrepreneurs, especially in the years immediately after setting up a company. However, every year that goes by without making any pension contributions is a year less for any savings to grow and help provide for retirement."

Acas publishes workplace disability discrimination guide

Acas has published a new free guide, 'Disability discrimination: key points for the workplace', to help employers identify, prevent and deal with disability discrimination.

The guide covers different types of discrimination such as direct discrimination or failure to make reasonable adjustments. It also explains the areas of employment where discrimination can take place, such as recruitment and dismissal, and how employers should handle complaints and grievances. Steve Williams, Acas Head of Equality, said: "We have published this new free guide to help employers understand the basics around equality and disability discrimination, as falling on the wrong side of the law can result in a costly employment tribunal."

IPO warns customers not to be fooled by imitators

The Intellectual Property Office has issued a warning to intellectual property owners about unsolicited reminders offering to renew or register their patent, trade mark or registered design for a fee.

Although the IPO is the only body that can issue reminders about UK IP rights, several intellectual property owners have been misled by 'official-looking' reminders. Anyone who has received a misleading reminder should contact the IPO at: 'misleadinginvoices@ipo.gov.uk'.

Do you need live help with your self assessment return?

HMRC will not send paper statements or payslips to self-assessment taxpayers to remind them of the 31 January 2016 filing and payment deadline. The only exception to this is for taxpayers who submitted their 2014/15 tax return by 31 December 2015, and who have not opted for digital-only communications from HMRC.

Anyone who needs to complete a self-assessment return must still make sure it is filed by 31 January 2016. Joining HMRC's live self assessment sessions throughout January makes perfect sense, especially if you need help to complete your return. HMRC staff will be on hand to take your questions and give answers to help you with your returns.

Responsible lending rises by 45% in one year

Members of Responsible Finance (formerly the Community Development Finance Association) lent nearly £251 million to UK firms, social enterprises and individuals during 2015. This compares to £173 million lent in 2014.

According to the 2015 Responsible Finance report, social enterprises received loans totalling £126 million, and loans worth a total of £98 million were provided to 11,440 mainstream business borrowers, including 10,000 start ups. The total number of loans made increased from 56,200 in 2014 to 57,800 in 2015.

Fall in local authority health and safety inspections

Over the last six years, the number of health and safety inspections carried out by local authorities has dropped by 61%, according to a discussion paper for the HSE and Local Authority Enforcement Liaison Committee. There has also been a 95% fall in proactive inspections carried out by local authority environmental health officers over the same period, with one quarter of councils not carrying out any proactive inspections.

Proactive inspections are carried out to prevent the occurrence of the most common infections, explosions, falls and accidents in the highest risk sectors. Reactive inspections - responding to accidents, complaints and requests - also decreased by 36% between 2009/10 and 2013/14.
