# Supersonic car to be star attraction



The Bloodhound supersonic car will be the headline attraction at this year's Get up to Speed with Engineering and Manufacturing (GUTS) event to be held at Magna Science Adventure Centre, Rotherham at 10.00am to 6.00pm on Wednesday 20 April.

The Bloodhound supersonic car is a four wheeled, 7.5 tonne, 135,000 bhp jet and rocket powered car which will challenge for the world land speed

record and is set to ultimately break the 1000mph barrier: faster than the speed of sound! Many of the parts for the car and engineering are designed and manufactured in the Sheffield City Region, with many of the companies exhibiting at the event.

This year GUTS is aiming to break a few records of its own too! Now in its 6<sup>th</sup> year this annual event is on target to outstrip its previous highest attendance last year and with over 1,500 bookings so far is on track to reach over 2,000 people during the day. Chairman of the Organising Committee and Co-founder of the work-wise Foundation John Barber says "This year is shaping up to be the biggest, best, most interactive yet. We have so many exhibitors and attractions that The Big Hall at Magna just can't house them all so we have had to extend into other parts of the building!"

GUTS is a free highly interactive event for students, parents and teachers showcasing the best of the engineering, manufacturing and technology sectors, its employers and employment opportunities in the region.

# **Competition opens to host Great Exhibition of the North**

Towns and cities across the North are invited to bid to put on the two-month exhibition, celebrating the best of art, culture and design.

The Government is contributing £5 million towards the exhibition itself and a further £15 million into a legacy fund to attract further cultural investment in the Northern Powerhouse. The exhibition will showcase the great creative and cultural sectors across the North, to help boost the economy in the region.

Culture Minister Ed Vaizey said: "The

Great Exhibition of North is a fantastic opportunity to promote the very best of Northern art, culture and design. Investment in our arts and culture not only benefits these sectors but, as we have seen from Hull being named UK City of Culture 2017, can drive regeneration of whole towns and cities."

The competition will close in June this year and the chosen venue will be announced in the Autumn.

Sir Gary Verity, chief executive of Welcome to Yorkshire, has been appointed by the Chancellor George Osborne to chair the Great Exhibition Board that will report to Ministers on the applications. Sir Gary said: "There are many towns and cities across the North of England that have what it takes to host the Great Exhibition of the North and I hope that many of them put in a bid.

"We will be showcasing our art, design and culture to the world in 2018 and high quality bids are an essential part of ensuring that we deliver an incredible Great Exhibition."

The Department for Business has announced the five areas which will pilot the new Science and Innovation Audits. ### DCLG announces £1.8 billion for Growth Deals

England's 39 Local Enterprise Partnerships will be able to apply for a share of £1.8 billion funding from the latest round of Growth Deals to support local economic growth and job creation projects.

The Communities Secretary Greg Clark has said the deals will improve opportunities to secure significant investment from overseas for LEP areas. The Growth Deals are part of the Government's £12 billion Local Growth Fund to build vital infrastructure, improve skills and create new jobs. LEPs are able to apply for a share of the Local Growth Fund, including the Growth Deals, until summer 2016.

# Report reveals extent of business crime



Almost one in four small business owners do not report any crimes committed against their business to the police, according to FSB research. Almost half of firms also believe reporting the crime would not achieve anything positive, while 38% do not think it would lead to a prosecution.

In the last two years, 66% of FSB members have been victims of cyber crime and 48% have been victims of non-cyber crime. The research also identified that a

third of small firms believe business crime is increasing.

Gordon Millward, Regional Chairman at FSB said: "Crime affects all businesses, but it impacts smaller firms the hardest as they cannot absorb the unexpected costs. The fact that businesses are not reporting crimes shows a real breakdown in trust and confidence in the police".

BIS consulting on protections for small firms in non-regulated sectors

The Department for Business is consulting on whether further protections are needed for small and micro businesses, including sole traders, when purchasing goods and services from other businesses in non-regulated sectors.

The Department would like feedback on whether small firms have sufficient support and protection when negotiating contracts and whether they are aware of their current protections, or if further protections are needed. In particular, the Department is looking for feedback from individual firms, trade bodies and research and academic organisations.

The consultation closes on 9th June 2016.

### New legislation for charities

The Charities (Protection and Social Investment) Act has been made law after it received Royal Assent on 16 March 2016. The Act applies in England and Wales only and introduces new powers for the Charity Commission, including a procedure to disqualify charity trustees, and also extends the circumstances when someone is automatically banned from acting as a trustee.

However, the majority of its provisions are not yet in force. The Commission is expected to publish guidance before certain provisions of the Act take effect, and those regarding disqualification are not expected to be implemented for at least a year.

British Business Bank invests £5 million to support small business finance

The British Business Bank is to invest up to  $\pm 5$  million in its partnership with business loan provider Liberis.

Liberis claims the investment will help provide funding to more than 2,000 small firms in 2016 through its Business Cash Advance service. The service provides funding from

 $\pounds$ 4,000 to  $\pounds$ 300,000 to small firms based on their future credit and debit card sales, which is then paid back via a pre-agreed percentage of the firm's credit or debit card transactions.

# Research reveals earnings gap between employed and self employed workers



Research from the Social Market Foundation has found a significant gap between the earnings of employed and self-employed workers in the UK. According to 'Tough Gig: Low-Paid Self-Employment in London and the UK', which was published in March 2016, around half of self-employed workers are earning no more than two thirds of the median UK wage. This compares to just 22% of employees.

The Social Market Foundation report also highlights the impact of the National Living

Wage on the earnings gap. From 1st April 2016, employees aged 25 or over must be paid at least  $\pounds$ 7.20 per hour. However, the report estimates that 1.73 million self-employed workers will continue to receive less than the statutory minimum amount.

# Value of EFG loans continues to decline

The number of small and medium-sized firms receiving finance through Governmentbacked Enterprise Finance Guarantee loans has fallen year on year since 2009, according to figures from the British Business Bank.

In the last quarter of 2015 only 482 EFG loans worth £56.2 million were provided, in comparison to 2,030 loans worth £201.6 million in the second quarter of 2009. The EFG was designed to support small and medium-sized businesses that have been unable to access funding through the banks, by having the Government act as guarantor to the loan. Chancellor George Osborne announced in his Budget on 16 March 2016 that the EFG will be extended until at least 2018.
